## WKXS "LYNYRD SKYNYRD & ZZ TOP WITH SPECIAL GUEST, UNCLE KRACKER" CONTEST OFFICIAL RULES

The Station will conduct the WKXS "Lynyrd Skynyrd & ZZ Top with special guest Uncle Kracker" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
